MEMORANDUM OF COOPERATION

BETWEEN THE CENTRAL ELECTION COMMISSION AND KOSOVO COMPANY FOR DISTRIBUTION AND SUPPLY WITH ELECTRICITY FOR UNINTERRUPTED ELECTRICITY SUPPLY FOR KQZ, KKZ OFFICES AND MUNICIPAL WAREHOUSES, CENTRAL WAREHOUSE, NUMBERING AND RESULTS CENTER (QNR) AND ALL VOTING CENTERS (QV) AND VOTING PLACES (VV) FROM 10.10. 2017 TO 31.12.2017

Signatory Parties to the Memorandum

- I. The Central Election Commission (hereinafter referred to as the KQZ)
- II. Kosovo Electricity Distribution and Supply Company (hereinafter referred to as KEDS)

Article 1

Purpose

The Memorandum of Understanding between the Central Election Commission (KQZ) on one hand and the Kosovo Electricity Distribution and Supply Company (KEDS), on the other hand, defines the conditions and the method of cooperation regarding the supply of electricity for the needs of the KQZ during the Local Election process of October 22, 2017.

Article 2

Responsibilities of Kosovo Company for Distribution and Supply with Electricity

2.1. Provide uninterrupted electricity supply to the QNR, in the road Pristina-Fushë Kosovë - Industrial Zone, Central Warehouse of KQZ, Municipal Election Commissions (KKZ) Offices and KKZ Warehouses, in all municipalities of Kosovo and KQZ/SKQZ offices on Migjeni Street no.21 former Ljubljana Bank building, first floor, no.21 in Prishtina, during the period from 10.10.2017 to 31.12.2017.

2.2 While providing uninterrupted electricity supply to all QVs and VVs, two days prior to Election Day, during Election Day and two days after Election Day.


Article 3
Responsibilities of KQZ (Central Election Commission)

3.1. The KQZ is obliged upon the signing of this Memorandum to provide KEDS with the specified QNR lists such as the addresses of the offices of KQZ, KKZ and Municipal Warehouses of QNR, Central Warehouse of KQZ, and the list of all QV and VV with the correct addresses.

Article 4
Final Provisions

1. For the realization of the objectives arising from this Memorandum, the KQZ and KEDS will authorize certain persons from the line of their officials.
2. Making concrete the duties and responsibilities arising from this memorandum, the parties agree to do so after signing the agreement.
3. This Memorandum shall apply until the Parties mutually agree in writing otherwise.
4. Any dispute, disagreement or breach, termination or invalidity shall be settled on the basis of understanding and partnership.
5. This memorandum shall enter into force on the date of signature by both parties.
